



PROXY

Per Texas State Property Code 209.00592, An electronic vote counts toward quorum, and is cast either by an internet (HOA) website or by email (to Association Manager). If you submit your ballot electronically, you do not need to include a proxy. However, if you are unable to attend and you mail or fax your ballot, you will need to include this completed proxy with your ballot. Your ballot and/or proxy must be received before the vote closes, or it will not be counted.

Check Only ONE Proxy Choice: If neither choice, or both are checked, the proxy will be designated to a board member for quorum purposes only.
