The Annual Election Meeting was held and there was a tie between two (2) candidates. **The Runoff Election Meeting will be held on Friday October 18, at 5:00 pm.** The purpose of this meeting is to **announce the new Board Member.** There is a Ballot, Agenda, and Proxy, with this Meeting Notice, **please read them. See the instructions below on how to submit your vote. Please vote in this Runoff Meeting.**

Quorum must be met, or the meeting may have to be rescheduled again, **so please cast your ballot for your Runoff Candidate.** The easiest way to vote is on your HOA Website. **An Electronic vote is one submitted on the HOA website, by email, or by fax. If you vote one of these three (3) ways, no proxy is needed as it is counted for quorum. [Instructions to vote are below.](#)** You must be **registered and logged into the HOA website to vote.** When you register, on the profile page you will see 2 small boxes. **It is important to opt in to receive newsletters / emails to receive any information from the HOA. Only one (1) vote per home. If you send your ballot by USPS Mail, you must include the completed Proxy.**

Here are the 4 ways you can vote. Remember, an electronic vote does not require a proxy.
